That upward mobility, it has often been said, coincided with Jews' increasing alienation from religion and Jewish nationhood. Buber and Rosenzweig famously critiqued bourgeois German Judaism as a craven attempt to establish social respectability to facilitate Jews' entry into the middle class through a vapid, domesticated Judaism. But Mendelssohn, Zunz, and Hirsch saw in bourgeois values the best means to serve God and the authentic actualization of Jewish tradition. Through their learned, creative Bible translations, these scholars presented competing visions of middle-class Judaism that affirmed Jewish nationhood while lighting the path to a purposeful, emotionally-rich spiritual life grounded in ethical responsibility.

Onder ~~de Swakvuit~~ ~~Asse van de Spring~~ besloot Anne Frank na de oorlog een boek te publiceren. Haar dagboek zou daarvoor als basis dienen. In maart 1945 stierf Anne Frank op vijftienjarige leeftijd in het concentratiekamp Bergen-Belsen. De enige overlevende van de familie, Otto Frank, zorgde ervoor dat het dagboek van zijn dochter toch gepubliceerd werd. In 1947 verscheen *Het Achterhuis*. Het is sindsdien een van de meest gelezen boeken ter wereld. Het is in meer dan dertig landen verschenen en er zijn meer dan zestien miljoen exemplaren van verkocht. "Eén enkele Anne Frank ontroert ons meer dan de ontelbaren die net zo leden als zij, maar wier beeld in de schaduw is gebleven. Misschien moet dat ook zo zijn: als we het leed van alle mensen moesten en konden meelijden, zouden we niet kunnen leven."
